

- Increase capacity of pediatric practices to support children and adolescents with restrictive eating disorders
- Educate clinicians in Family Based Treatment, the gold standard for restrictive eating disorders
- Improve patient outcomes
- Be part of a learning community for behavioral health providers and pediatric care teams





- ECHO = Extension for Community Healthcare Outcomes
- A tele-mentoring program designed to create communities of learners by bringing together health care providers and experts using didactic and case-based presentations
 - "All teach, all learn"
 - Encourages knowledge exchange
 - Utilizes technology
 - Promotes case-based learning



What does an ECHO session look like?

- Introductions/Housekeeping (5 min)
- Lecture (followed by short Q&A) (15-20 min)
- De-identified Case Discussion (25 min)
 - Case Presentation by spoke or faculty
 - Facilitator summarizes case; asks for clarifying questions
 - Recommendations/Discussion
 - Facilitator summarizes recommendations
- Wrap-up (5 min)

ECHO sessions are smaller than the typical webinar to allow for more active participation. Much of the learning comes from the discussions
